<u>Future Meetings – Discussion and potential setting of special meetings.</u>

If NCTC JPA wishes to consider invoking AB 361 virtual meetings for subsequent meetings:

a. The proclaimed state of emergency must remain active; or

b. State or local officials have imposed or recommended measures to promote social distancing;

AND

c. Not later than 30 days after teleconferencing for the first time under the AB 361, and every 30 days thereafter, the board shall again make the following findings by majority vote:

The board has reconsidered the circumstances of emergency, and at least one of the following circumstances exist:

1. The state of emergency continues to directly impact the ability of the members to meet safely in person; or

2. State or local officials continue to impose or recommend measures to promote social distancing.

The Metrolink K-9 deputy conducted 90 station checks, one layover facility inspection, participated in four streetcar operations, and responded to one unattended baggage call.

#### **DEFINITIONS OF DETAILS AND OPERATIONS**

#### STREET CAR DETAIL

A street car detail is when field deputies during their routine daily train rides work in conjunction with the conductor to open a limited number of doors on the train and check patrons for valid fare while they board the train. This is usually conducted at either Union Station or the end of the line station. Only those with valid fare are permitted to board the train

#### VIPR Operation

A VIPR Operation is conducted by Metrolink deputies, a K9 deputy and agents from the TSA and Homeland Security (Federal Air Marshalls). Some agents from Homeland Security work in plain clothes and others in uniform during the operations. Our deputies will conduct fare enforcement on board the trains while our K9 deputy will walk the trains searching for potential explosive devises. The agents conduct visual observations of patrons searching for potential suspicious activity or actions by patrons.

#### Platform Fare Enforcement

Platform Fare Enforcement is when deputies during their routine daily activities, monitor a station platform and enforce that everyone on the platform has proper fare.

#### <u>Train Rides</u>

A train ride is when field deputies during their routine daily train rides, ride a train for more than three stops. While on board the train, deputies will check fares, enforce laws and provide a visible presence on the train.

#### **ROW Enforcement Detail**

A ROW Enforcement detail is when field deputies during their routine daily duties, monitor and check the ROW's for trespassers, homeless encampments and debris placed on to the tracks.

#### **ROW Enforcement Deputy Activity**

There are currently six deputies and one sergeant assigned to the ROW Enforcement Team. They are responsible for patrolling the ROW's for trespassers and homeless encampments. They work in conjunction with outside agencies to remove homeless and their encampments from the ROW and provide outreach to the homeless. They also work in conjunction with Metrolink to conduct clean up of those encampments.

#### Joint Grade Crossing Operation

A Joint Grade Crossing Operation is when Metrolink deputies, along with at least one outside law enforcement agency team up to monitor and cite drivers for vehicle code grade crossing violations within a certain area. They spread out over several crossings within a given area.


#### Grade Crossing Detail

A Grade Crossing detail is when field deputies during their routine daily duties, monitor a single grade crossing for a period of time when a train is expected to cross through the crossing. This is an individual detail and not a large scale operation.






### **1 YEAR LOOK BACK – SAFETY INCIDENTS**




### 2020 - 2022 YEAR TO YEAR COMPARISON

The California High Speed Rail Authority Palmdale to Burbank Project Section has reached a major milestone with the conclusion of the public comment period for the Draft Environmental Impact Report and Environmental Impact Study (Draft EIR/EIS) as part of the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA) processes.

Throughout the 90-day comment period, which occurred from September 2 through December 1, 2022, the Authority undertook a robust outreach effort, including:

- Printed notices and display ads in local newspapers in multiple languages
- Hard copy mailing to 44,000 stakeholders
- E-blasts and social media ads
- Printed and digital copies of the Draft EIR/EIS made available at 10 public libraries
- Virtual and in-person meetings and briefings (including an all-Spanish meeting)
- Bilingual virtual open house (English and Spanish)
- Participation at community events and festivals

The California High Speed Rail Authority received more than 400 comments, including those from federal, state, and local agencies, state and local elected officials, businesses, organizations and individuals. This volume of comments is comparable to what we have received for other Draft EIR/EIS released by the Authority and reflects strong engagement by stakeholders. Comments focused on impacts to property values, impacts of tunneling on properties, noise and vibration and the cost of the project, among many others. Our team is carefully reviewing the comments and will be developing responses to the comments in the coming months.

As always, we appreciate the NCTC JPA interest in this important project and look forward to continuing to work with you as we move towards the next milestone – the release of the Final Environmental Impact Report and Environmental Impact Study, which is expected late next year.

#### 1. High Desert Intercity High Speed Rail Project in Federal NEPA Environmental Process

The HDC JPA submitted the High Desert Intercity High Speed Rail Project petition for Reevaluation to the Federal Railroad Administration (FRA) and Surface Transportation Board (STB) in April 2021. FRA is the Lead Agency for the NEPA environmental process.

The High Desert Intercity High Speed Rail Project objective is to progress with the FRA NEPA process to receive the Record of Decision (ROD/NOD), Notice of Determination approval in Summer, 2023. With California Environmental Quality Act (CEQA) concurrence, this will complete environmental clearance for the high-speed rail project to advance to the next phase of Project Development such as 35% design engineering.

#### 2. Seek Federal and State Grant Opportunities

On December 20, 2022, the FRA released the Corridor Identification and Development Program Notice of Corridor Proposals and Funding Opportunity with applications due to FRA by March 20, 2023. HDC Agency staff met with both FRA and CalSTA staff to discuss the HDC JPA interest in submitting grant applications for the HDC High Speed Rail Project. Concurrently, HDC Agency staff met with LA Metro Planning staff to request Metro allocate \$8.5M in local matching funds (\$500,000 Federal Corridor ID & \$8M CA TIRCP) from Measure M HDC Expenditure Plan funds for the federal and state HDC grant applications. On January 26, 2023, the Metro Board of Directors is scheduled to review the HDC Measure M \$8.5M local matching funds HDC Agency request.

#### 3. Metro HDC Intercity Rail Service Development Plan & Funding Plan

The Metro HDC Intercity Rail Service Development Plan & Funding Plan is nearing conclusion. The Plan is funded with \$3.5 million of HDC Measure M funds, \$1.375 million in CalSTA 2018 Transit Intercity Rail Capital Plan State grant funds under the Network Integration category, and \$625K from Brightline West (\$250K in cash and \$375K of in-kind contributions). The Plan is expected to be complete by Summer 2023.

4. High Desert Intercity High Speed Rail Project Map & Project Highlights



2016, High Desert Corridor Multi-purpose corridor receives California CEQA clearance which included a highway and high-speed rail line.

2018, High Desert Corridor Joint Powers Authority (HDC) supports study of an alternative to the HDC 2016 Locally Preferred Alternative (LPA), Highway Component and decides to focus on first phase as the High Desert Intercity High Speed Rail Project of the LPA.

2020, Caltrans declares No Build for the highway portion. Metro and San Bernardino County Transportation Authority focuses on widening SR18/SR138 as a continuous 4-lane highway between the Antelope and Victory Valleys.

April 2021, HDC JPA submits Reevaluation petition to Federal Railroad Administration (FRA) and Surface Transportation Board (STB) to receive NEPA clearance and receive the Rail Project Record of Decision (ROD/NOD).

High Desert Intercity High Speed Rail Project proposes a 54-mile corridor (Palmdale to Victor Valley) that can be traveled in roughly 30-minutes with two-stations.

One Station in Palmdale and One Station in Victor Valley: Proposed integration with Palmdale California High Speed Rail Station and Brightline West Desert Xpress Victor Valley Station.

The estimated cost of the HDC Rail Project is \$5.54B in year of expenditure dollars, calculated based on the assumed service operations in 2031 and an escalation rate at 3% per year. Final Design and Construction is estimated at \$3.6B of the \$5.54B Project estimate. Environmental clearance could accommodate doubled track. Future design and cost considerations will determine.

Nealy all the 54-mile route of the HDC high-speed rail project is within Equity Communities in the high desert communities of Los Angeles and San Bernardino Counties.

The NCTC JPA October 2022 Executive Director Update will cover the following items:

#### 1. SR14 SAFETY & MOBILTY IMPROVEMENTS in the Santa Clarita and Antelope Valleys

NCTC staff in cooperation with Caltrans District 7 and Metro Multi-Modal Planning are pleased to present that all 6 Segments of the SR14 projects with be entering Project Approval/Environmental Document (PAED) in Spring, 2023. This is a major milestone for the critical safety and mobility projects for the North Los Angeles County region the NCTC Board has clearly directed become "shovel-ready" for grant opportunities. Please see the January 23, 2023, NCTC JPA joint Caltrans Metro Board Report Item 17 on this agenda.

#### 2. ANTELOPE VALLEY LINE UPDATE

On December 2, 2021, Metro Board of Director certified the Environmental Impact Report (EIR) for the Antelope Valley Line Service and Capacity Improvements. As a funding partner, the NCTC JPA is excited the projects will begin Final Design in February 2023 with construction expected to begin in Spring 2026 with Revenue Service in Fall 2027. The NCTC JPA submitted a funding commitment letter for the Metro and Metrolink Funding January 2023 agreement (Attached).

According to Metrolink, the AVL Projects Total Cost is \$302.9 Million with Funding secured of \$137.5 Million (CA TIRCP and NCTC Measure M MSP local), therefore, on December 6, 2023, Metrolink/Metro submitted a supplemental request of \$165 Million of CA TIRCP Cycle 6 grant funds. Please see the January 23, 2023, NCTC JPA Metrolink Update Board Report Item 11 on this agenda.

#### 3. I-5 CAPACITY ENHANCEMENTS HOV & TRUCK LANE

Metro I-5 construction is well underway in the Santa Clarita Valley (January 2023 Construction Notice attached). Metro along with the contractor have been communicating construction activity with the community through media and social media sources while holding regular virtual meetings.

#### SUBJECT: METROLINK ANTELOPE VALLEY LINE CAPITAL AND SERVICE IMPROVEMENTS

#### ACTION: APPROVE RECOMMENDATIONS

#### RECOMMENDATION

#### CONSIDER:

- A. EXECUTING a Funding Agreement (FA) with the Southern California Regional Rail Authority (SCRRA) in the amount of \$16,563,581 for final design services for the Antelope Valley Line Capital and Service Improvements Project (Project) to a 60% design level; and
- B. AUTHORIZING the CEO or their designee to negotiate and execute all agreements necessary to implement the Project.

#### **ISSUE**

Metro has programmed funds and delegated to SCRRA the responsibility to complete the final design phase of the Project. A FA is required for SCRRA to award contracts for final design plus other engineering supporting functions and maintain the schedule to deliver the Project in Fiscal Year (FY) 2027.

#### BACKGROUND

In 2020, Metro in partnership with SCRRA, was successful in receiving \$107,050,000 in State Transit and Intercity Rail Capital Program (TIRCP) funds for the Project, leveraging \$113,800,000 in North County Measure M Multi-Year Subregional Program (MSP) funds. The Project funding is for the construction of four capital improvement projects on the Metrolink Antelope Valley Line (AVL), which will enable additional commuter rail capacity, leading to 30-minute bi-directional service to Santa Clarita and 60-minute bi-directional service to Lancaster by 2028.

Consistent with the 2020 TIRCP program schedule, Metro has completed preliminary engineering and environmental clearance for the Project ahead of schedule. In December 2021 the Metro Board certified the final environmental impact report for the Project in accordance with California Environmental Quality Act (CEQA) requirements and adopted a finding that the Project is statutorily exempt under CEQA. On December 8, 2021, the Notice of Exemption was filed with the Los Angeles County Clerk's office.

Since the completion of the environmental phase of the Project, Metro and SCRRA have worked in close partnership to develop the scope of work and roles and responsibilities for the final design phase of the Project. As part of the Metro Board's approval of the environmental documents in December 2021, the Board directed SCRRA to take the lead to advance the Project through the final design phase. Subject to Metro Board approval of Recommendations A and B, SCRRA will complete the design procurement and expeditiously award final design contracts for the Project, including bid documents to support construction and pre-construction right-of-way acquisition activities.

#### DISCUSSION

The three capital projects to be funded for final design as part of the Project FA are as follows:

- 1) Balboa Double Track. The Balboa Double Track Extension will extend the existing Sylmar siding approximately 6,300 feet north from Balboa Boulevard to Sierra Highway.
- 2) Canyon to Santa Clarita Double Track. The Canyon Siding Extension will extend the existing Saugus Siding by adding approximately 8,400 feet of new track between Soledad Canyon Road and Golden Oak Road with optional platform-to-platform pedestrian undercrossing configuration options.
- **3)** Lancaster Terminal Improvements. The Lancaster terminal improvements will include expansion of the existing yard with two new 500-foot-long and one 1,000-foot-long train storage tracks and provisions for fueling, plus a center platform with pedestrian underpass options.
- Note a fourth project, **Brighton to McGinley Double Track** was also environmentally cleared by Metro and is currently designed to the 90% level as part of the larger Brighton to Roxford Double Track project. This project will be advanced separately by Metro.

#### Project Benefits

The Metrolink AVL is a critical lifeline service for residents in the Santa Clarita and Antelope Valleys which are geographically isolated from the greater Los Angeles area, especially when the bottlenecked Interstate 5 / State Route 14 interchange is congested or closed. More frequent Metrolink service from Los Angeles to Santa Clarita and Lancaster will lead to a doubling of service levels on the AVL by 2028. This additional service throughout the day, in both directions, will lead to a significant increase in mobility options for some of the most disadvantaged communities in Los Angeles County. Elimination of automobile trips will lead to reduced congestion on the SR-14 freeway plus greenhouse gas reduction benefits, as quantified through the previous environmental efforts.

#### Metrolink SCORE Program

With the transition of the Project from Metro to SCRRA, SCRRA has incorporated the Project into the larger Southern California Optimized Rail Expansion (SCORE) Phase 1A Program. SCORE is SCRRA's \$10 Billion capital improvement program consisting of grade crossing, track, signal, and

station improvements, providing capacity for more frequent service, to be implemented prior to the 2028 Olympic Games.

#### TIRCP and Measure M Funding

To meet grant funding and Project schedule requirements, final design activities must commence in early 2023. As part of the overall TIRCP grant application, \$113,800,000 in North County Measure M Multi-Year Subregional Program (MSP) funds was committed as local match. Because the TIRCP funding for the Project is for right-of-way and construction only, the MSP funds must be drawn down first for the final design phase of the Project.

#### NCTC and Metro Board Programming Actions and Project Budget

To date, both the North Los Angeles County Transportation Coalition (NCTC) and Metro Boards have approved and programmed \$19,624,000 of Measure M Transit Program MSP funds in FY20 to FY25 for Project environmental and design activities. The amount of \$3,060,419 was spent on preliminary engineering and environmental clearance, leaving a balance of \$16,563,581 available for final design. The \$16,563,581 of already programmed and available MSP funds is sufficient to initiate the final design phase of the Project to the 60% design level. See Attachment A for the TIRCP grant funding plus the programming of MSP funds for the Project. Recommendation A will execute the FA between Metro and SCRRA and enable SCRRA to award contracts with design firms for the final design to the 60% design level, anticipated to occur in February 2023.

Inclusive of SCRRA agency costs, program management consultant, contingencies and third-party agreements, the total anticipated cost for the final design phase and supporting functions of the Project exceeds the \$16,563,581 of previously programmed funds authorized for design activities. The actual full final design and supporting engineering activities budget for the Project is estimated at \$33,107,189.

#### Future NCTC and Metro Board Programming Actions

At the next NCTC quarterly Board meeting, scheduled to occur in April 2023, the NCTC will approve additional Measure M Transit Program MSP funds in the amount of approximately \$17 million to fund the full final design of the Project. See Attachment B for NCTC's commitment and intent to program additional funds for the remainder of the 100% final design of the Project in April 2023. As part of the annual update to the Metro Board on the North County Subregion Measure M MSP, staff intends to bring a concurrent action to program additional funds and adjust the cash flow for the budget for the final design to the 100% design level.

#### Funding Agreement and Scope of Work for Final Design and PS&E

The FA between Metro and SCRRA will establish roles and responsibilities, terms and conditions, and project budget and schedule for SCRRA to receive \$16,563,581 in Measure M MSP funds for the Project to the 60% design level. SCRRA will take an action item to concurrently approve the FA at the SCRRA Board meeting on January 27, 2023. SCRRA is leading the design services procurement effort and intends to award contracts to the 60% design level in February 2023. Metro will be the key funding stakeholder and will be at all Project Development Team (PDT) meetings and involved in all design decisions.

The Scope of Work (SOW) includes engineering consulting services for the final design, some

environmental studies to support the final design (Mitigation Monitoring and Reporting Plan - MMRP), program management consultants, SCRRA agency costs, right-of-way acquisition services, third-party support, bid support, and contingencies, to the 60% design level. The Project is anticipated to start in February 2023, with the final design complete in mid-2025.

Staff will provide updates to the Board on a regular basis regarding design elements, schedule, cost impacts, and stakeholder interaction. Towards the end of the final design phase of the Project, Metro will return to the Board with an updated construction funding plan and to commit remaining MSP funds for construction.

#### DETERMINATION OF SAFETY IMPACT

The final design for the Project will be done to the latest SCRRA, California Public Utilities Commission (CPUC), Federal Railroad Administration (FRA) and other regulatory agency safety standards and requirements.

#### FINANCIAL IMPACT

The project team does not anticipate an impact to the FY23 adopted budget. The Chief Planning Officer or designee and respective Project and Cost Center Managers will be responsible for programming funds and budgets for future years under project 474502.

#### EQUITY PLATFORM

The proposed funding agreement will facilitate final design services for the Project that is anticipated to serve many marginalized communities upon completion. 32% of potential riders along the AVL corridor live in SB 535 Disadvantaged Communities (DACs) census tracks. 58% of the potential riders along the AVL corridor live in AB 1550 Low-Income Communities census tracks. An additional 6% live in Low-Income Buffer census tracts. Of the 11 cities and communities of Los Angeles County that this project will provide increased service to, nine are Equity Focus Communities. The Project will serve North LA County, which is very ethnically diverse, more so than other regions in the Metrolink system. The AVL has the highest percentage of African American riders (19%). Overall, 73% of Metrolink North LA County riders are non-Caucasian versus 66% systemwide. The AVL has the lowest percentage of riders with annual household income over \$50,000 at 65% as compared to the systemwide average of 80%. The increase in ridership will reduce congestion and air pollution in adjacent disadvantaged communities along the high volume I-5 and SR-14 highways.

#### **IMPLEMENTATION OF STRATEGIC PLAN GOALS**

Recommendation A supports strategic plan goals 1, 3 and 4. The FA supports Metro's partnership with SCRRA and NCTC to improve service reliability and mobility, provide better transit connections throughout the network, and implement the following specific strategic plan goals:

- Goal 1.2: Improve LA County's overall transit network and assets;
- Goal 3.3: Genuine public and community engagement to achieve better mobility outcomes for the

people of LA County; and

 Goal 4.1: Metro will work with partners to build trust and make decisions that support the goals of the Strategic Plan

#### ALTERNATIVES CONSIDERED

The Board could choose not to approve the authorization to execute the FA with SCRRA. This is not recommended since SCRRA is currently in the procurement process and \$107,050,000 in State TIRCP funds would be at risk if the two agencies do not stay on schedule to complete construction by 2028. Another alternative is for Metro to complete the final design phase of the Project instead of SCRRA. This is not advised since the Metro Board previously directed SCRRA to lead and complete the final design phase.

#### NEXT STEPS

Subject to Board approval, the CEO or their designee will negotiate and execute the FA with SCRRA so that SCRRA can award the contracts for the final design to the 60% level, anticipated to occur in February 2023. Staff anticipates returning to the Board in April 2023 to request programming of additional Measure M MSP funds for the final design phase of the Project to the 100% design level. The FA between Metro and SCRRA will be amended as additional MSP funds are made available by the Metro Board. Staff will return to the Board with periodic updates on the final design, funding, schedule, etc.

On behalf of the North Los Angeles County Transportation Coalition JPA (NCTC) member agencies: Los Angeles County 5<sup>th</sup> Supervisorial District, the Cities of Lancaster, Palmdale, and Santa Clarita located in North Los Angeles County, I am pleased to **submit this letter strongly supporting and continuing NCTC JPA funding commitments to the Metro Antelope Valley Line (AVL) Capital and Service Improvements next phase of final design.** 

The proposed AVL projects will provide higher frequency, more reliable and convenient rail transit to attract more Metrolink ridership on the AVL and provide relief for the severely congested Interstate 5 and State Route 14 corridors.

The NCTC JPA members **have committed \$113.8M in Measure M tax-payer Multi-Subregional Program** (**MSP**) **funds** toward the AVL service improvements implementation and Metro and Metrolink jointly submitted the AVL Capital and Service Improvements SB1 Transit and Intercity Rail Capital Program (TIRCP) and was awarded \$107 million for the four capital projects with a total budget of \$220.85M.

On **April 17, 2023**, as part of the NCTC JPA annual MSP funding update, the NCTC JPA Board will be expected to **program a total of \$36.98M to fully fund the final design phase** of the AVL capital projects. The NCTC JPA Board and Members will reaffirm the **AVL improvement projects as their top transit priority** for the North Los Angeles County subregion.

The combined projects will implement four strategic capital infrastructure improvements along the AVL that will unlock Metrolink's ability to run faster and more frequent service along the 76-mile alignment between the City of Lancaster in North Los Angeles County and Union Station in Downtown Los Angeles, serving

rural, suburban, and urban communities including the Cities of Lancaster, Palmdale, Santa Clarita, Sylmar, San Fernando, Burbank, Glendale, and Los Angeles including unincorporated communities such as Acton and Agua Dulce.

Many of these areas offer important concentrations of workforce labor and affordable housing and include disadvantaged communities with higher-than-average transit dependency. The projects will improve service to major employment centers and other regional destinations, including Hollywood Burbank Airport, while accommodating the population and employment growth that is forecasted.

The AVL is the only Metrolink route that operates entirely within LA County, and it is the only high-capacity transit corridor that connects the cities of Lancaster, Palmdale, Unincorporated LA County 5<sup>th</sup> District, Santa Clarita, Burbank, Glendale, and Los Angeles. The Metrolink corridor runs parallel to the 5 and 14 Freeways, providing critical congestion relief seeking to lower vehicle miles traveled. Due to the mountainous terrain of the northern portion of the AVL, the average speed for this line is approximately 40mph with passenger rail travel time of approximately two hours between Lancaster and LA Union Station (LAUS).

In many ways, the AVL is a model for the current regional rail system, and it will play a critical role in expanding regional mobility, as outlined in the State Rail Plan and Metrolink's SCORE program.

In closing, on behalf of the North Los Angeles County Transportation Coalition JPA members, I am pleased to submit this letter strongly supporting the Metro Antelope Valley Line Capital and Service Improvements next phase of final design and reaffirm NCTC JPA commitment to program a total of \$36.98M at the April 17, 2023, NCTC JPA Board meeting.



  - North County Transit Coalition committed \$107.05M in Measure M MSP sub-regional funds as local match to the TIRCP grant application to construct the four AVL projects.
- 2020 Metro awarded \$113.8M in TIRCP funds for the four capital projects.
- 2021 Metro completed environmental clearance for the three remaining capital projects.
- 2022 Metro advanced Brighton to McKinley to a 90% final design level.
  - Metrolink initiated procurement for design for the three-remaining capital projects.

#### **1-5 NORTH COUNTY ENHANCEMENTS PROJECT**

#### **Overhead Sign Removal**

#### Summary

As part of the I-5 North County Enhancements Project, Metro's contractor OHLA-USA, will be removing overhead signage throughout the project corridor. This activity requires replacing existing signage with temporary signs, followed by installing permanent signage when construction is complete. OHLA-USA will complete this construction activity at multiple locations:

- January 2023: Two signs along northbound I-5 between Magic Mountain Pkwy and Newhall Ranch Rd.
- February 2023: Two signs along southbound I-5 between SR-14 and Weldon Canyon Rd.

#### **Upcoming Work/What to Expect**

Removal of two existing overhead signs at the California Highway Patrol Weigh Station on **Tuesday, January 17, 2023** between **10pm and 4am**, and on northbound I-5 at Newhall Ranch Rd on **Wednesday, January 18, 2023** between **10pm and 4am**. Additional closures will take place as a contingency on Thursday, January 19, 2023, if needed. Closures and detours:

- Full closure of northbound I-5 between Magic Mountain Pkwy and SR-126.

  - Detour 2: Exit northbound I-5 at Magic Mountain Pkwy, continue northbound on The Old Road, enter northbound
     I-5 at Hasley Canyon Rd


